BETWEEN PARTIES

This agreement is made between Ace Dog Supplies and the person hiring the collar as listed above, hereafter called "the Hirer".

WHEREAS

(a) Ace Dog Supplies is the owner of the anti barking collar.

(b) The Hirer wishes to utilise the collar and enter into this agreement on the following conditions:-

AGREED CONDITIONS

The period of hire shall be from _____ to _____ being equal to or greater than a 2 week period.

The hirer may choose to either:

- Hire the Innotek BC-200 Bark Collar and agree to all hire terms and conditions
- Or
- Hire and then Purchase the said Innotek BC-200 Bark Collar and have all hire fees paid (excluding delivery or any other consumables) deducted from the purchase price of the said bark collar.



Hire Terms And Conditions

- i. This agreement is for the hire of the Innotek BC-200 Bark Collar that is owned by Ace Dog Supplies. The Hirer agrees that they shall not transfer or assign the unit or this Agreement to any other Party. The Hirer further agrees to return the unit to Ace Dog Supplies at the end of the hire period, that is unless the hirer wishes to purchase the bark collar.
- ii. The Hirer shall pay Ace Dog Supplies the minimum sum of \$39.90 to cover the minimum hire period upon entering into this agreement. The fee is calculated at \$19.95 per week. The Hirer shall also pay Ace Dog Supplies a security deposit as defined above. The deposit will be charged and retained by Ace Dog Supplies in the event of loss or damage caused or occurring to the collar during the period of hire. Upon return and verification that the collar and any additional accessories are fully operational, the remaining deposit amount will be refunded to the Hirer. The hirer also agrees to pay the standard \$15 delivery fee which is not refundable.
- iii. If the Hirer returns the collar later than the due date indicated above, further hire charges will apply. Additional hire will be charged at the weekly rate of \$19.95 per week or part thereof.
- iv. Ace Dog Supplies agree that they will inspect the condition of the hire collar prior to the delivery of the Bark Collar and affirm that the unit is in working order. Upon the return of the hired bark collar, Ace Dog Supplies will record the date of return and further inspect that the device and all accessories are returned in its pre-hired condition.
- v. The Hirer agrees that in the event that the Collar is lost or stolen, the Hirer shall be liable to pay the replacement value of the Collar, being a total forfeit of the security deposit.
- vi. At the sole discretion of Ace Dog Supplies in the event of damage or loss, the repair or full replacement value of the unit, plus any hire fees due shall be paid by the hirer from the pre-mentioned security deposit.
- vii. Ace Dog Supplies assumes no responsibility for any damage or loss occurring during delivery of the bark collar from the hirer back to Ace Dog Supplies. It is recommended that the hirer take out the necessary postage insurance to protect themselves from such a scenario.
- viii. Should the Hirer discover at any time during the rental period that the unit or any part of the unit is not operating correctly, the hirer agrees to contact Ace Dog Supplies immediately. No refund will be given for the hire fees or deposit if the unit is returned at the end of the rental period and is found to be faulty or damaged.
- ix. The hirer agrees that Ace Dog Supplies is not responsible for any accidents or injuries to the hirer, property or pets and the hirer agrees to indemnify Ace Dog Supplies against any claims or other matters that may arise in relation to such accidents or injuries.
- x. The Hirer has thoroughly read and received all of the required literature on this unit and fully understands that this unit is not guaranteed to change any unwanted behaviour in their pet. The Hirer understands that no refunds on the hire fee will be given if this unit does not change or modify their pets' behaviour. The hire fee is for the entire minimum selected period; refunds will not be given on days remaining on the rental period if the unit is returned before the expiry of the rental period.
